### RE: PUPILS WHO HAVE SAFEGUARDING NEEDS OR AN EHCP

Leeds College of Building aims to provide a safe and supportive environment for all members of the College community. The College also wants to ensure that it can support the needs of any students who have disclosed additional learning support needs, including those who have High Needs or an EHCP.

Therefore, it is important that we receive any relevant information relating to safeguarding and or additional learning support needs at least **10 days** before the proposed start date for the student for any student.

With this in mind, it is extremely import that you follow the guidelines set out below for any relevant students.

#### Step 1

- Complete the application form online at this address: Skills Academy Form (lcb.ac.uk)
- Provide the college with an up-to-date EHCP if one is in place prior to completing a learning agreement if the pupil is High Needs funded.
- Inform the college of any safeguarding issues –

is the student at risk to themselves or others?
Or do they have any specific safeguarding support needs?
Is the student in local authority care?

• Let us know if an individual pupil risk assessment or Risk Assessment Management Plan is in place.

Unfortunately, in some cases where checks have not been carried out for a student who may present a risk to themselves or other in the College community, **the student will not be able to attend the provision until the checks have been done.** Therefore it is important that any risk based information is disclosed and shared with us as soon as possible. This will help to avoid any delays.

## Step 2

If the application form states that the student has a criminal conviction or a safeguarding issue (only those that may indicate that the student may be a risk to themselves or others), the College will contact you within 5 working days to discuss any arrangements.
